

**Young ICOM Members' Travel Grant Programme 2024  
APPLICATION FORM**

**Support for Young Members' participation in the 14<sup>th</sup> COMCOL annual conference,  
9-12 October 2024, Amsterdam**

To encourage young colleagues to participate in ICOM and COMCOL activities, we announce up to two travel grants of one thousand Euros (€ 1000) each for ICOM / COMCOL members who intend to take part in the 13<sup>th</sup> COMCOL Conference from 9-12 October 2024 in Amsterdam.

Criteria young members travel grant:

- **35 years of age or under,**
- able to write and understand English fluently,
- museum professionals working for or with museums/heritage institutions and students with a demonstrably relevant position for collecting/collecting strategies,
- individual members of ICOM and of COMCOL,
- having submitted a proposal for the conference which was accepted,
- be aware that priority will be given to young members ( $\leq 35$  years) from countries belonging to Categories 4, 3 and 2,
- be aware that young members who have received grants in the last three years (2021, 2022, 2023) will not be given priority for a grant in 2024,
- up-to-date with their membership dues for 2021, 2022 and 2023. New ICOM members who joined the organization in 2023 must have paid their dues for 2023 and 2024,
- must have a passport and be able to travel.

All documents should be sent in electronically.

**Deadline of Application:** The deadline for applying is **July 5<sup>th</sup> 2024 at midnight**. Submissions received after this date and time will not be considered.

*Selection process: Applications will be evaluated by the COMCOL board.*

**All applications must include:**

1. the completed and signed application form
2. a 500 words motivation for attending the 14<sup>th</sup> COMCOL Conference answering the following questions:
  - *What are the most important reasons for your motivation to participate in the conference?*
  - *How will your participation in the conference benefit your museum or museum communities you work with?*
  - *How do you plan to disseminate the information and knowledge gained at the conference upon your return to your home country?*
3. indication of the estimated travel costs from your home city to Amsterdam
4. copy of a valid travel document (passport, identity card)
5. the applicant's curriculum vitae indicating training, work experience, publications as well as current work responsibilities within his/her institution (maximum one page)
6. letter or email of approval of their proposal
7. letter of recommendation from the Chair of the applicant's National Committee.

Each grantee will be required to submit a questionnaire **within two weeks following the meeting** stating his/her experience and contribution to ICOM and COMCOL activities, and to submit an article of approx. 1000 words in **the next [Comcol Newsletter](#)**, which describes his/her conference experience and reflects on the conference.

**The resources for this programme are limited. Applicants are required to comply with the eligibility criteria stated in this document.**
